


EUROREGION BALTIC ACTION PLAN 2023 – 24



Bornholm, 2nd March 2023

Background

Established in 1998, Euroregion Baltic (ERB) is a politically solid and well-anchored cross-border cooperation platform in the southeast of the Baltic Sea region, representing regional authorities and local authorities' associations in seven regions in four countries – Denmark, Lithuania, Poland and, Sweden.

Euroregion Baltic (ERB) Action Plan for 2023-24 was adopted on 2nd March 2023 at the beginning of the new Presidency within the organisation assumed by the Regional Municipality of Bornholm, Denmark. The plan outlines the joint actions for 2023 when Bornholm chairs the ERB.

After 2023, in 2024, the Presidency will be assumed by the Swedish region Kronoberg.

The Action Plan is elaborated on a bi-annual basis to streamline better 'stakeholders' resources and concretise results they expect from ERB cooperation, from longer-term strategic actions, while allowing better reporting on the achievements after one year.

Vision and mission of Euroregion Baltic by 2030

The ERB 2030 Agenda builds on the achievements of the first 20 years of successful cooperation and provides an updated strategic framework by defining Euroregion Baltic's vision.

- 1. South Baltic Agenda
- 2. Baltic Sea Region Agenda
- 3. European Agenda
- 4. Youth and People-to-People Agenda
- 5. Green and Blue Growth Agenda

Therefore, the Euroregion's mission is to undertake joint initiatives aiming to strengthen and promote cooperation among the local and regional authorities of the Parties of the Agreement and contribute to the sustainable development of the Baltic Sea Region with a particular focus on the South Baltic area.

ERB cooperation is built around three main types of activities:

- Lobbying activities to represent and promote common interests;
- Implementation of strategic initiatives and projects complementing the local and regional agendas of the member organisations;
- Exchange activities seek a collaborative approach to common challenges and progress in the cooperation's innovation and operational efficiency.

 - 3) a more connected Europe, by enhancing mobility;
 - 4) a more social and inclusive Europe, implementing the European Pillar of Social Rights;
 - 5) a Europe closer to citizens by fostering the sustainable and integrated development of all types of territories and local initiatives.
- 3. The 2030 Agenda for Sustainable Development.

Synergies between the goals of the ERB cooperation and the four priorities of the Swedish EU Presidency 1st Half 2023 will be highlighted: security - unity, 2) competitiveness, 3) green and energy transitions and 4) democratic values and the rule of law.

ERB regards programmes such as Erasmus+, Horizon Europe, Life, Creative Europe, the European Social Fund+ and the Interreg regional funds, especially the Interreg Baltic Sea Region Programme and Interreg South Baltic Programme, as crucial to enhance cross-border cooperation between the ERB Member organisations and a possible source of financing for joint initiatives.

Bornholm presidency priorities 2023

The Presidency in 2023 will focus on four main priorities, presented below, that will be reflected strongly in the activities for the Euroregion Baltic during the year:

- Strengthening the ERB cooperation platform, by following up the preparations of providing ERB with a legal status, as a European Grouping of Territorial Cooperation (EGTC), to reestablish a permanent international secretariat – and to celebrate the ERB 25th Anniversary as well as organise the Annual Stakeholder Forum
- 2. Interreg South Baltic Programme 2021-2027, through active participation in the programme monitoring committee, promoting the programme and its calls, and by facilitating capacity building activities
- 3. Blue and Green Growth, through the Water Core Group and the establishment of a new ERB task force for green transition (circular economy and renewable energy)
- 4. Youth Cooperation, by supporting the Youth Board and promote the youth cooperation in the ERB regions

Improving ERB organisation, leadership and visibility

To ensure the Action Plan implementation, ERB will also improve organisational, executive and communication capacities. To achieve this, the ERB will:

- 1. Apply for a legal status, as European Grouping of Territorial Cooperation (EGTC)
- 2. Re-establish a permanent international secretariat, as well as organising monthly meetings with the regional ERB secretariats
- 3. Use the ERB 25th Anniversary to improve the visibility through an exhibition and an updated promotion brochure
- 4. Improve the organisational support of the Youth Board
