On behalf of the Association of Polish Communes, Ms Agata Nazar proposed three changes to the 2013 – 2-14 Action Plan:

- Change 1: extend the result "decision on legal status for ERB" of the internal action: strengthening ERB internally, with "discussion on ERB Statutes, proposals for possible changes";
- Change 2: add an extra result to the internal action: strengthening ERB internally, phrased as: "Forum of local level stakeholders held in Poland";
- Change 3: add an extra result to the action: supporting youth cooperation within ERB Youth Board, phrased as: "25th Jubilee International Competition of Fine Arts of Children and Youth from Euroregion Baltic We Are From the Sea".

A discussion followed in response to the proposals presented.

ERB Executive Board:

- did not agree to include Change 2 proposed by the Association;
- took note of the information presented by the Task Force on Cohesion Policy,
- agreed to the merging of the ERB Task Force on Cohesion Policy and ERB Task Force on EUSBSR,
- took note of the information presented by the Task Force on Labour Markets.
- took note of the information presented by the Water Core Group,
- took note of the ERB Youth Board action plan.

11.40 11. 4th Annual ERB Forum

(ERB 2012 – 2013 Action Plan \rightarrow Internal Action: reinforcing stakeholder approach)

Mr Valdas Pučkorius informed the Executive Board of the discussion held during the ERB secretariat meeting regarding the fourth annual forum of ERB stakeholders. Ideas were discussed of:

- involving representatives of the local authorities in the ERB area,
- promoting results of the projects implemented within the South Baltic Programme 2007 – 2013,
- presenting new cooperation possibilities of the South Baltic Programme 2014 – 2020,

• focusing on opportunities related to tourism development.

A discussion followed during which Ms Krystyna Wróblewska proposed that the EUSBSR flagship project called "Promote the cultural and natural heritage" with Pomorskie as a leader, could be presented at the Forum. Mr Karl Holst suggested that the Forum also touches upon entrepreneurship involving business dealing with promotion. Mr Niels Chresten Andersen thought it necessary to combine EUSBSR with practical expectations from the municipalities and therefore proposed that results of South Baltic projects are shown. ERB President, Mr Per Ole Petersen summed up by saying that tourism is present in many aspects: energy saving, transport, infrastructure and urging the ERB secretariats to work towards the preparation of a comprehensive proposal for the next Board meeting.

ERB Executive Board members agreed that 4th Annual ERB Forum which will take place on 4th September 2013 in Kalmar will target local stakeholders within ERB and focus on financial possibilities available in the new programming period in ETC programmes to support local actors in addressing their local challenges, including tourism.

12.40 Head of IPS, Mr S. Demkowicz-Dobrzański presented the terms of reference for the purchase of legal expertise in order to assist Euroregion Baltic in the acquisition of a legal status.

Member of the Board, Mr Grzegorz Nowaczyk proposed a change in the ERB Statutes in its introductory part where the explanation is provided of the Lithuanian delegation. Following the establishment of a new body representing Klaipeda region, i.e. the Association Klaipeda Region, he will propose that the Association Klaipeda Region replaces the Regional Development Council in Klaipeda Region which is named in the current version of the Statutes.

ERB Executive Board members:

- approved the terms of reference for the purchase of legal expertise,
- approved the change in the ERB Statutes proposed by the Association in the following wording: "Lithuanian delegation, consisting of the representatives of the Association Klaipeda Region (successor to the Klaipeda County's Governor Administration who was the original signatory of the Agreement), consisting of Municipalities of Klaipeda, Neringa and Palanga, as well as District Municipalities of Klaipeda, Kretinga, Silute and Skuodas.".
