13.25	5.	Interreg South Baltic programme, information
		Niels Chresten Andersen, member of the South Baltic programme Monitoring Committee, informed about the outcome of the MC online meeting 27 th April 2023
		It was the 'old' MC for the programme 2014-2020. Only small savings from finalised projects, so no more calls in the 'old' programme. The Annual Implementation Report for 2022 was approved.
		Financial support to the regional contact points will continue from the 'old' programme until the end of 2023. Future support will come from the new programme 2021-2027.

		Mr André Nord, newly elected and acting chairperson of Youth Board, informed about the situation and work of YB, including several new members.
		He expressed hope that all members of the Youth Board will be able to meet in Brussels late September, where a chairperson will be elected.

Ms Antje Schreyer from Kalmar Region informed about the situation and work of the Water Core Group, based on a presentation made by the WCG expert, Mr Tobias Facchini.

The WaterMan project was introduced, supported under the Interreg Baltic Sea Region programme, highlighting the drought problems, giving some facts about the 3-years project and partners, work packages, budget and coming events.

13.55 8. **EGTC, information**

Mr Piotr Zwolak from Warmia-Mazury region informed about the recently receieved response from the Polish Ministry of Foreign Affairs (MoFA) in relation to the informal EGTC consultation.

MoFA has consulted also the other Polish ministries, including the Ministry of Finance with a response of 6 pages. It is mainly horizontal issues, financial effects and some other comments.

Warmia-Mazury region will translate the response into English and distribute to the ERB secretariats, who will go through the remarks and discuss them at their next online meeting 30^{th} May.

Decision:

The secretariats will forward the response from the Polish ministries to the Executive Board, including revised draft EGTC convention and status.

The Board will have a two-weeks written procedure to decide on a recommendation from the secretariats for the further process.

If the Board approves to continue the process with a formal EGTC application, there will be a parallel process:

- 1) Preparing and sending the formal application to the Polish Ministry of Foreign Affairs,
- 2) Regional and national approval of the revised application.

14.10 9. Financial status

Mr Marcin Zuchowski, Association of Polish Communes, informed about the ERB joint account and recent spending.

The state of 15.05.2023 is EUR 47 746,80 in the ERB accounts.

Mr Piotr Zwolak, Warmia-Mazury Region presented a proposal for changes of the ERB website – www.eurobalt.org:

- 1. To delete the section "Learn with us"
- 2. To delete a presentation from Kaliningrad Region
- 3. To keep the section "Mobility Core Group, to be later used for the Climate Change Task Force
- 4. To discuss if the ERB Executive Board minutes should be kept at the website

Decision:

The ERB financial status will be forwarded to the Board together with the draft minutes, and with a possibility to comment within 14 days.

The proposed changes of the website were approved, and Board minutes should be kept on website.

The Board also agreed to ask Ms Anna Dudziak to assist in a revision of the ERB brochure. The secretariats will follow up.
